Dear Lion President,

Following you will find a letter from the Multiple District 13 legal counsel with regard to the obligation of Lions Clubs to file a 990 with the I.R.S. For most clubs this can be accomplished in a matter of minutes by filing the 990N online. The filing deadline is November 15, 2014.

#### All clubs are required by law to file a 990 with the I.R.S. yearly!

If you do not file, your club will lose its non-profit designation, and you will have to follow the steps outlined to regain it, which include paying a fine of \$400.00 or \$850.00 depending on the income of the club.

If your club has already lost its non-profit status, you must regain it to operate as a Lions Club.

I urge you to carefully read the following material, and take the necessary steps to comply.

Additionally, enclosed you will find a reporting form to be returned to the district which, when returned, informs us that you have filed a 990 this year with the IRS. Please fill in the needed information, and return by December 1, 2014 to:

# All Lions Clubs Must File a Tax Return

In September, every club president received a mailing (reprinted in this newsletter) from District Governor Jeff explaining the obligation of every Lions Club to file a 990 form with the I.R.S. by November 15<sup>th</sup>.

Filing is not optional, and there is no threshold of income below which clubs do not have to file. To repeat, every club must file. If clubs do not, or have not, filed for three years, they lose their non-profit designation. Simply put, that means that your club could become a taxable entity, and is liable to pay taxes on all income generated by the club including dues, donations, project income, interest, etc.

For most clubs filing can be accomplished online by filing a 990N form. This is an "online" only postcard, and the majority of clubs can use this option. If you choose the 990N, your filing can be accomplished in a matter of minutes. For the very few clubs with income above the criteria for a 990N, a 990EZ or 990 must be filed.

If you club has not been filing a tax return for a three year period, you will find that you will have lost your non-profit designation (known as a 501(c)4). To regain your non-profit status, your club will have to begin the process that will include a filing back returns and paying a penalty to regain it.

For a number of years at the District's Officer Training Schools, we have informed clubs of this obligation to file a 990. The district has on numerous occasions presented the seminar, "Legal Issues for Lions Clubs" at its Officer's Training School and District Conventions, and we will continue to educate and offer our assistance.

Please carefully read the mailing, and if your 501(c)4 has been lost you will need to begin the steps outlined in the mailing to regain it. If you need assistance, please contact District Governor Jeff. He is assembling a team to help clubs through this problem.

Re: Compliance with the 990 filing requirement of 501(c)(4) organizations

Dear Ms. Roll and the Council of Governors:

David Risen has discussed with our office the problem of local Lions Clubs who have failed to file the required annual 990 forms. Many of these clubs have lost their 501(c)(4) status or are the verge of doing so. Dave requested that we give you our opinion on the issue as well as the means to correct the problem.

It is our legal opinion:

- (1) The IRS requires that all clubs must file the required 990 forms once a year.
- (2) The district offices need to institute a reporting mechanism to insure that the Clubs have complied with the filing requirements.
- (3) Any Club that has lost its 501(c)(4) designation must be required by LCI to have their status reinstated or not operate as a tax exempt organization.
- (4) Any Club that continues to operate as a tax exempt organization is subject to major fines and penalties, and could be required to file as a tax paying organization.

We have discussed these issues further in the attached papers. We also refer you to the Lions Clubs International website. It contains useful information on this subject.

#### REQUIRMENTS TO FILE 990 PROCEDURES TO REPAIR REVOCATION OF 501(c)(4)

#### Nonprofit association is a state definition.

A nonprofit association is the form of business organization that applies to a charity or social organization. It is non-profit because of the way it is organized and structured.

Non-profit status is filed with the Ohio Secretary of State. Continued Existence status must be filed every 5 years. The form is on the Ohio Secretary of state website.

Clubs must also file with the **Ohio Attorney General- Charitable Section**. They will notify the Club when paperwork is due or missing, including the 990s. It is best to give them 3 e-mail addresses for 3 individuals who will be responsible for taxes, forms, etc. These forms are on the Ohio Attorney General – Charitable Section website.

<u>Tax exempt status</u> means that the organization does not pay taxes. This is an IRS definition. Lions clubs are 501(c)(4) from Lions Clubs International. This status applies to civic leagues and social welfare organizations. The letter of determination is on the LCI web site.

Local Lions Clubs are subject to the rules and regulations required of 501(c)(4) organizations. Although the 501(c)(4) status is a group status determination, each club must maintain that status by complying with the IRS tax filing requirements (even if no tax is paid).

## 501(c) (4) must file annual tax returns - even when they don't pay taxes

We are concerned that Clubs may think that if they don't pay taxes, so that they don't need to file a return. In fact, they still have to file a form of the 990.

There are several different forms. All are available on the IRS website.

990N is very simple. It is a post card and filed on the internet. It asks a few very simple questions.

This form would apply to all Clubs that have income under \$50,000.00 and minimal assets

**990EZ** form applies to Clubs with income between \$50,000.00 and \$200,000.00. It is a 4 or 5 page form,

It is more complicated that the 990N, but still could be handled easily by most Clubs.

The 990 form is required of all Clubs with income over \$200,000.00 and/or with substantial assets.

This is a more complicated form and probably would need a CPA or tax professional.

There may be other 990s if the Clubs have special circumstances. This would definitely require professional help.

The 990 form is due 5 months after end of the fiscal year. Since most Clubs operate on the July thru June fiscal year, the form is due November 15<sup>th</sup>.

#### Recommendations:

We recommend that the Clubs set up a mechanism to insure that the Form is filed in a timely manner. We recommend that each Club amend their By-laws or policies to include a system of checks and balances.

For example: (1) The President must sign the form, but the Treasurer should prepare the form.

or (2) Set up a Financial Committee to oversee the handling of money. This would include the Treasurer, a Vice President, a person named by the President from the Board and a person not on the Board. This committee would conduct the annual audit, prepare the 990, and oversee the money handling of the Club.

We further recommend that the district Lion Office require that the local Clubs file a copy of the 990 with the Office. This would notify the District Office to that the Clubs have complied.

#### If don't file, you lose your tax exempt status

The cancellation is automatic if they don't file 3 consecutive filings

IRS will notify you if you are going to lose your status. However, this is where we have found another problem. Clubs have too many addresses and contact people. Every President or Treasurer gave his/ her personal address and contact information. Then the President or Treasurer moved on. The notice goes to their old address and they are no longer involved with the Club.

Recommendation: Each Club must have an official address. We suggest a PO Box or a designated person who will have a long term commitment as the designated Statutory Agent.

Note: We found that Lions often have two or three different names. The official name and the name used by the Club are often different. If you know the EIN number, this is unique like a social security number. If you don't know the EIN, use the city option. .

This web site will tell you if the Club's tax exempt status has been revoked and when it was revoked. This date of revocation is important, see below.

#### What if you lose the tax exempt status.

You need to take action to have it restored and time is important. IRS will work with you if you act in a timely manner.

The process you need to follow depends on how long you have been out of compliance.

If miss the filing of the 990 before the revocation occurs

Revocation will occur automatically if you miss filing 3 consecutive returns. If you are a 990N or 990EZ filer and you have missed one, two or three filings, just file the missing returns. There will be no problems with IRS.

#### If it has been less than 15 months since the date of revocation

- File the missing returns.
- 2. File a new 1024 application and a form 8718. Mark the top of the pages with "Revenue Procedure 2014-11, Streamlined Retroactive Reinstatement". The forms are available in the IRS website.
- 3. Pay the appropriate fee either \$400.00 or \$850.00 depending on the income of the Club. See Form 8717.

IRS will not assess a penalty or back taxes.

#### If it has been more than more than 15 months since the revocation

- File the missing returns.
- 2. File a new 1024 application and a form 8718. Mark the top of the pages with "Revenue Procedure 2014-11, Streamlined Retroactive Reinstatement". The forms are available in the IRS website.
- 3. Pay the appropriate fee either \$400.00 or \$850.00 depending on the income of the Club. See Form 8717.
- 4. Attach a reasonable cause statement explaining why the tax forms were filed late. Be as specific as possible. IRS does not like being told that you didn't know that the tax form was required to be filed. Be as honest as possible. Examples: We are an all-volunteer organization. Our Treasurer or other officer was to file the form. He/she did not do so because... There were problems beyond the control of the Club, explain..

In the letter, explain what steps the Club has taken to insure that future tax returns will be filed in a timely manner. Examples: We have amended our by-laws. The Treasure or other officer is assigned the duty to prepare the tax form. Our President must sign the return. (checks and balances) We have put together a Financial Committee to prepare the return, etc.

IRS will not assess a penalty or back taxes for three years. . BUT they can assessed taxes, penalties, and interest for the other years.

IRS will consider how timely these steps were followed after the revocation was discovered. Did the Club have a history of the failure to comply with the tax laws and filing requirements.

The penalties could be \$20.00 per day for every day that they are not filed. The penalty could be a maximum of \$10,000.00 or 5% of gross receipts.

If penalties are assessed, they can be appealed. The assessment letter will explain how to do it. The letter to appeal should state that the payment of the fees would be a hardship. That the organization has taken steps (explain) to avoid the problem in the future.

#### If the Club is not given reinstatement

The Club is now liable for taxes. They need to file the standard Corporation taxes on an 1120 tax form. Remember that their status as an Ohio non-profit organization is a structural designation, not a tax designation. Note: this will only affect the Club. It will not affect the contributors since 501(c)(4) donations are not tax deductible anyway.


